### Directions to Duke Island Park (Map it online: 189 Old York Rd, Bridgewater, NJ)

A) Traveling **South on 287**, after passing **Rt. 78**, take **202/206 South**

B) Traveling **North on 287**, take **22 West**, then take **202/206 South**

1) From Somerville Circle follow **202 South** about 0.25 miles (*note: if you are on 202 S there are no signs for Somerville Circle, you will go over it half mile after Route. 22*)

2) At the **1<sup>st</sup> Traffic Light** make a **Jughandle left** onto **First Ave** (567)

3) After about 1 mile at the **2<sup>nd</sup> Traffic Light** make a **right** onto **Somerset St / Old York Rd** (567)

4) After about 1.5 miles you will **pass a Krauszer's** and reach an open field on your left. Proceed to make a **Left turn** into **Duke Island Park**.
